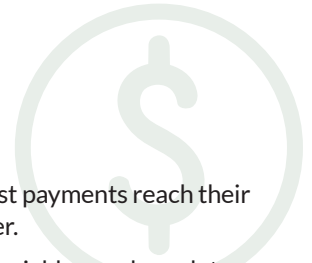

Each year, Guthrie County REC retires patronage capital to current and former members. While most payments reach their intended recipients, some checks go unclaimed. Our goal is to return every dollar to its rightful owner.

FIXED CHARGE REDUCTION NOTICE

Guthrie County REC's power provider, Central Iowa Power Cooperative, has completed the sale of its share of the Duane Arnold Energy Center, eliminating ongoing decommissioning costs.

These savings were passed on to Guthrie County REC members through a reduction in the Purchased Cost Recovery Adjustment on the August electric bill for July usage, with an additional reduction taking effect on the September electric bill for August usage.

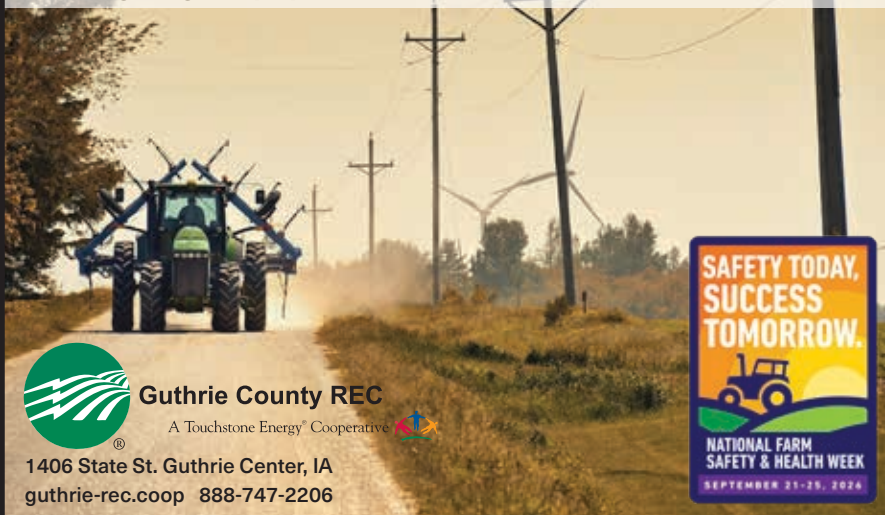

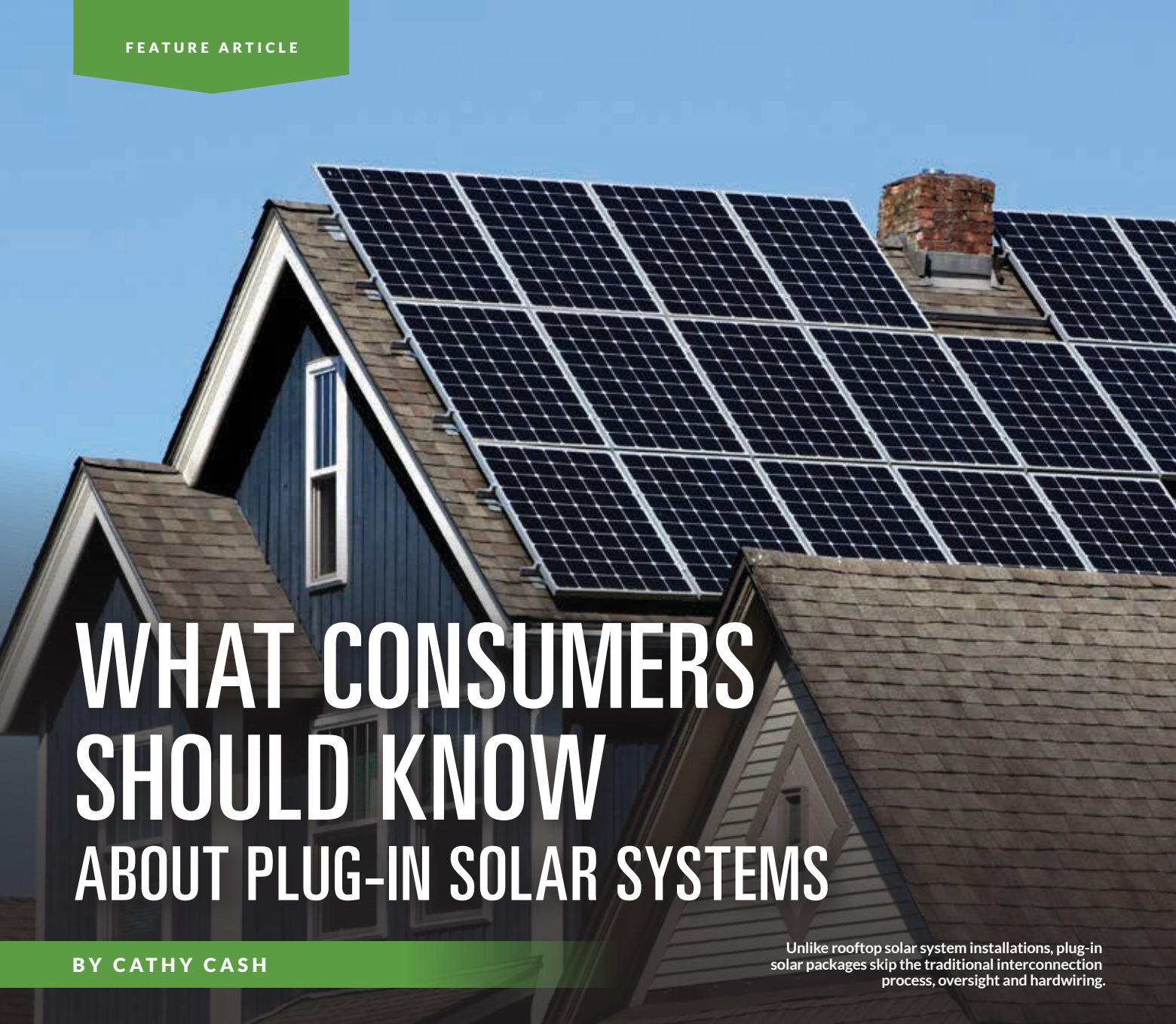

WHAT CONSUMERS SHOULD KNOW ABOUT PLUG-IN SOLAR SYSTEMS

Unlike rooftop solar system installations, plug-in solar packages skip the traditional interconnection process, oversight and hardwiring.

It seems easy enough. You set up a solar panel or two and its small generator-type device outside, plug the thing into a wall socket in your house, and before you know it, electricity is flowing and lowering your power bill.

These portable, DIY solar energy systems can generate several hundred watts and are marketed like appliances that only require a regular outlet. But as plug-in solar becomes more popular, consumers should be aware that these products require important safety considerations.

So, what should you know about behind-the-meter, plug-in solar kits?

Safety comes first

First, these systems have the potential to put lives and property at risk. Electric utility leaders note that almost all of these devices lack U.S. safety requirements, such as certification under UL codes or standards. UL has only recently developed a safety certification for plug-in solar systems.

Unlike rooftop solar and electric vehicle charger installations, these plug-and-play packages attempt to bypass existing interconnection protocols, oversight and inspections.

If a home's wiring is not up to snuff to support plug-in solar, the consumer

wouldn't know because they didn't call a licensed electrician to install the equipment or an inspector who could spot that hazard.

That can be dangerous on multiple fronts, leading to overheated wires in a residence, property damage, fire and even worse, serious or deadly electrical shock.

"Plug-in solar introduces real safety risks at the consumer-member level," said Jeffrey Groenewold, National Rural Electric Cooperative Association (NRECA) senior energy solutions manager. "Existing residential wiring standards were not designed for generation through standard outlets,

so plug-in solar increases the potential for fire and shock hazards.”

A charged solar system can backfeed, or send electricity back to the grid, and re-energize power lines without your electric cooperative’s knowledge. This could be fatal for lineworkers.

“The evolving plug-in solar industry must work to ensure these systems are properly managed and controlled to prevent unintended backfeed,” said Groenewold. “This is critical to protecting cooperative lineworkers and keeping them safe when they are out working to restore power.”

Unplugging the system does not eliminate its risk. Contact with the power cord energized by the solar panels can cause devastating injury.

Will Morris, a consultant to NRECA Business and Technology Strategies Group, underscored that these systems are not harmless appliances and should not be treated as such, especially around children.

“When we were growing up, our parents taught us if you would just unplug a blender or an iron or something like that, you’re putting that device in a safe state. With this, it is the complete opposite,” he said. “If somebody has this on their patio plugged into an exterior outlet and they unplug it and drop it in a puddle ... you can get 800 watts going to you. That can be a real bad day.”

Weighing the costs and benefits

Then there’s the affordability factor. Is plug-in solar really a good deal?

The equipment for this behind-the-meter energy resource can cost a few hundred dollars to more than \$1,000, but its output, even in areas with plenty of sunshine, will shave only an estimated 40 to 80 cents per day off your power bill, according to industry experts.

“I would be very surprised if in our markets plug-in solar makes financial sense because the average cooperative consumer rates are pretty low,” said Morris. “It would take a long time to recover that investment.”

European apartment dwellers who face very high electricity rates have been eagerly buying “balcony solar” for a while and expect to pay off their investment in a couple of years, he said.

In Germany, where rates are particularly high, the plug-and-play packages are designed within the country’s safety mandates and must be registered with the grid operator.

“So, the German utility knows when that device is being utilized and that they have potential for energy to flow back into the grid,” he said.

But in the U.S., states are at various stages of potentially regulating plug-in solar to ensure safety.

“We’re at the Wild West phase of it right now,” Morris said. “You can buy a system and plug it in. It’s like buying a hairdryer, except the hairdryer is UL certified.”

Members are encouraged to contact their electric cooperative for knowledgeable advice on plug-in solar and to inquire about requirements for installing such a device.

“The bottom line is if you’re looking to lower your electric bill with some behind-the-meter device, please let your electric cooperative know,” said Groenewold. “Co-ops have a variety of programs to partner with you to save money and to do it safely.”

LEMON CREAM CHICKEN

- 2½ pounds chicken thighs, boneless and skinless
- salt, to taste
- pepper, to taste
- parsley, to taste
- paprika, to taste
- creole seasoning, to taste
- 4 tablespoons butter, melted
- ½ lemon, juiced
- 6 garlic cloves, minced
- ½ cup cream
- ½ cup Parmesan cheese

Place chicken in a greased baking dish. Sprinkle liberally with seasonings. Mix butter, lemon juice, garlic and cream. Spread over chicken. Sprinkle with Parmesan cheese. Bake at 375 degrees F for 45 minutes, or internal temperature of 165 degrees F. Serves 4

- 4 chicken breasts
- 8 bacon slices
- 4 ounces chipped beef
- 1 cup sour cream
- 1 can cream of mushroom soup
- ½ teaspoon paprika

Wrap chicken in bacon. Cover bottom of 8x12-inch dish with chipped beef. Place chicken on top. Mix sour cream and soup, then pour over chicken. Sprinkle on paprika. Bake at 275 degrees F for 3 hours. Serves 4

YUM CHICKEN CASSEROLE

- 6 chicken breasts
- 6 slices Swiss cheese
- 1 package Stove Top dressing
- 1 can cream of chicken soup
- ½ can water
- ½ can milk

Place chicken in a 9x13-inch pan. Layer cheese on top of chicken. Mix dressing, soup, water and milk. Spread mixture over cheese. Bake covered at 350 degrees F for 1 hour. Let sit 5 minutes before serving. Serves 6

CRANBERRY ORANGE CHICKEN BREAST

- 4-6 chicken breasts, boneless and skinless
- 1 cup bread or cracker crumbs
- 2 tablespoons Parmesan cheese
- ¼ teaspoon garlic salt
- milk, for dipping
- oil
- ¼ cup sugar
- 2 teaspoons corn starch
- ½ cup cranberries, fresh or frozen
- ½ cup orange juice
- ¼ cup water

Flatten chicken breasts. Mix crumbs, cheese and garlic salt. Dip chicken in milk, then crumb mixture. Brown in oil, then place in 12x8-inch baking dish. Mix sugar, corn starch, cranberries, orange juice and water. Bring to boil, then pour over chicken. Bake at 350 degrees F for 45 minutes. Serves 4-6

STICKY CHICKEN RICE

- 2 cups uncooked rice
- 3 chicken breasts
- 1 teaspoon paprika
- 1 teaspoon chili powder
- 1 teaspoon onion powder
- 1 teaspoon garlic powder
- 1 teaspoon oregano
- salt, to taste
- pepper, to taste
- olive oil
- ½ cup soy sauce
- ½ cup honey
- ¼ cup rice vinegar
- 2 teaspoons sesame oil
- garlic, minced, to taste
- dash of sriracha
- 1 teaspoon ground ginger
- 2 teaspoons corn starch or arrowroot powder
- 2 tablespoons water
- 1 12-ounce bag frozen green beans or broccoli
- Garnish: avocado, sesame seeds

Wash and drain rice, cook according to package instructions. Meanwhile, cut chicken into strips or chunks. Season with paprika, chili powder, onion powder, garlic powder, oregano, salt and pepper. Cook chicken and seasonings in olive oil. Once chicken is cooked, add soy sauce, honey, rice vinegar, sesame oil, minced garlic, sriracha and ginger. Coat the chicken with sauce mixture. In a small bowl, stir together corn starch or arrowroot powder and water. Stir until the sauce thickens slightly, then add to pan. Add frozen green beans or preferred vegetables. Cover and continue cooking until vegetables are done. Plate the sticky chicken over cooked rice and garnish with avocados and sesame seeds.

CHICKEN CORDON BLEU SOUP

- 2 tablespoons butter
- 2 tablespoons oil
- 1 small head cauliflower, chopped
- 1 garlic clove, minced
- 1 medium onion, chopped
- 3 tablespoons flour
- 2 cups chicken broth
- 2 cups chicken, cooked and shredded
- 2 cups half and half
- 1 cup ham, finely cubed
- 1 tablespoon Dijon mustard
- 1 teaspoon salt
- ½ teaspoon pepper
- 2 cups Swiss cheese, shredded

Heat butter and oil in pan. Add cauliflower and cook 8-10 minutes, until crisp tender. Add garlic and onion, cook for 1 minute. Stir in flour, then whisk in broth. Bring to a boil and cook until cauliflower, onions and garlic are tender. Cool and then puree in blender. Return to pan and stir in chicken, half and half, ham, mustard, salt and pepper. Heat through. Add cheese and stir until melted.

SPICY CHICKEN TAGINE

- 2 tablespoons olive oil
- 1 pat butter
- 1 small onion, chopped
- 1½-inch piece fresh ginger, peeled and chopped
- 2 red chilies, seeded and chopped
- 3 fresh rosemary sprigs
- 1-2 cinnamon sticks
- 8 chicken thighs
- 6 ounces dried apricots
- 2 tablespoons clear honey
- 1 14-ounce can plum tomatoes, with juice
- water, as needed
- salt, to taste
- pepper, to taste
- 2 tablespoons fresh basil, chopped
- rice or couscous, optional

Heat oil and butter in medium-hot cast iron skillet or iron pot. Add onion, ginger and chilies until soft. Add rosemary sprigs and cinnamon sticks. Add chicken and brown on both sides. Add apricots and honey, then stir in tomatoes with juice. Add water, if needed to cover skillet bottom and apricots. Bring to a boil, reduce heat and simmer gently for 35-40 minutes. Season with salt, pepper and basil, stir. Serve over cooked rice or couscous. *Serves 4*

STITCHING TOGETHER A STRONGER COMMUNITY

ELLEN CAMPBELL'S VOLUNTEER SPIRIT BRINGS COMFORT AND CONNECTION TO OTHERS

For Ellen Campbell of Panora, volunteering has always been about bringing people together to help others. Now, her dedication has earned statewide recognition.

Ellen joined Stitch & Chatter after retiring from Panorama Schools in 2015, seeing it as a way to keep busy and be productive at the same time. What began with borrowed sewing machines has grown into a thriving volunteer group with members from towns as far away as Jefferson that create quilts, pillowcases, doll clothes and other handmade gifts for people throughout the community.

Handmade with care

"Each and every member is a delight to be around," Ellen said. "Without them, none of this could happen. We talk about who should be given a quilt, then invite the community to view them and see who will receive them. Probably the most rewarding part is the delivery of the quilts to so many people."



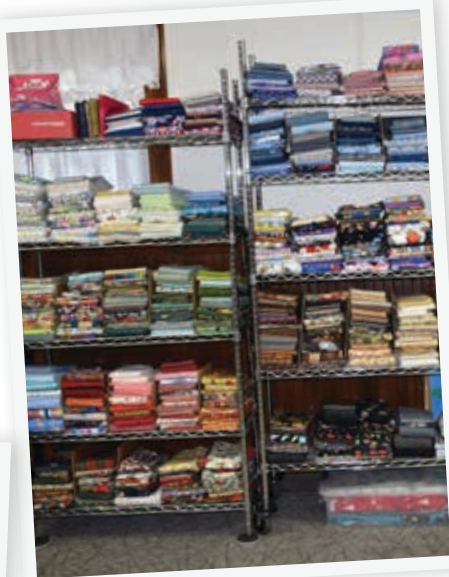

The group relies on donated fabric and grant funding to support its work, providing handmade items to organizations, including Children's Clothes Closet (Three C's), medical facilities and others in need. She also helps organize donations, write grants and coordinate the group's annual quilt showcase, where community members can see the finished projects before they are distributed.

In her nomination letter, Guthrie County REC member Luann Waldo said Ellen's leadership and commitment made her an easy choice for the nomination.

"Ellen likes to keep busy. She is very good at organizing whatever task is put before her," Luann shared of her longtime friend. "She has a talent of recruiting people to help her, but she never asks anyone to do anything that she won't do herself."

Luann added that the quilts are "made with love for fellow



citizens. It's a gift that shows the recipient someone cares about and for them."

Inspiring others to serve

Ellen hopes the recognition inspires others to get involved in their own communities.

"I would encourage others to find a group in their community they could join and discuss how they could help someone," she said. "Maybe random acts of kindness to a neighbor, business or even family member to bring a smile to their face."

"Belinda, during these 10 years, volunteers four days a week. She also stops at a store on her way to Albia from Iconium to bring in donated dairy to the food bank. She is dedicated, selfless and goes above and beyond to help others. Her sense of humor and patience help purchasers and the rest of the volunteers to be their best," remarked nominator Pat Merrick.

Helping Hands at work

Monroe County Helping Hands was established in 1985 and currently

operates out of an older building in Albia that was previously a laundry facility. There is a constant need for maintenance, and the \$3,000 Shine the Light donation will help to keep the facility in good working condition while also stocking the shelves of the food pantry section.

The thrift store is open to the public and operates on donated clothing and household goods from the community. The proceeds from thrift store sales benefit the food pantry, allowing Monroe County Helping Hands to purchase food monthly from the Food Bank of Iowa. The food pantry serves more than 200 people in need each month, and no one who asks for assistance is turned away.

A spirit of service

And what makes Monroe County Helping Hands such a longstanding blessing in the community are volunteers like Belinda. Marnie shared, "Belinda has a genuine concern for people. All people. She is invaluable and her dedication is priceless and irreplaceable."

Belinda has endured some difficult challenges recently, and her faith sustains her. She shared, "My biggest faith is in God. Without his grace and his mercy, I would not be the person I am today."

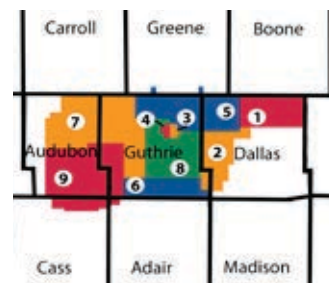

TEACHING KIDS TO SAVE: FROM LIGHT SWITCHES TO LIFELONG HABITS

Teaching your children to build good energy habits saves money on your electric bill today and sets them up for a lifetime of smart energy use. Here's how to get your family started on a household energy-saving adventure.

Safety first

When it comes to electricity, start with safety basics. Secure cords so appliances, lamps or other plugged-in items can't be pulled down. Use outlet covers and safety plugs to keep little hands from getting injured.

As they get older, teach children not to stick things in outlets. When they are old enough to use outlets, let them know they should never unplug something by pulling the cord. When playing outside, educate them to stay away from downed power lines, keep a safe distance from all electrical equipment and avoid the dangers of electricity near water.

Teaching energy habits

Keeping safety in mind, you can teach age-appropriate energy habits.

Turning off fans and lights when you leave a room is always a good habit to instill. Fully powering down TVs, computers and gaming systems reduces energy waste.

Keeping the refrigerator door open is a common energy waster for kiddos and some adults. Show them they can take a quick look inside and scan their options. If they need time to decide what they want, they can close the refrigerator while making up their minds.

Closing your home's doors is another way to keep heated or air-conditioned air inside. I wonder how many kids these days are asked if they were born in a barn or if they would even know what you mean?

Hot water is another area where families can save. In addition to

Building positive energy habits with your children can start with small steps, including turning off lights when leaving a room or installing energy-efficient bulbs.

reducing wasted water, using less hot water helps lower your energy bill. Heating water is typically the second-highest energy use in a home behind heating and air conditioning. Reduce energy use by turning off the water while hand-washing dishes, taking short showers and not overfilling the bathtub.

Gamify your bill

Review the electric bill with older children. Be sure to focus on energy use, which is shown in kilowatt-hours on your bill.

It's also a good opportunity to teach budgeting and household finances. If you save money on the electric bill, you may be able to do something fun with that money instead. Consider

a trip to mini golf, getting ice cream or choosing a longer-term goal to fund a weekend family trip.

Make it a game. Consider a family reward for using less energy than the previous month or the same month of the previous year, or an individual reward for the person who guesses how many kilowatt-hours you used that month. The winner gets to pick the movie for family night.

Exploring energy efficiency and conservation with your children doesn't have to be a chore. Find fun ways to build lifelong energy habits and save energy around your home.

Bill and Megan Gleeson faced every parent's nightmare when they were told their 2-year-old son had cancer. Their son, Reid, died in 2020 when he was 5 years old after a courageous battle with brain cancer. Megan was nominated for Shine the Light by Kathy Wunderlich, who is a member of Eastern Iowa Light & Power Cooperative.

Reid was an active and fun-loving boy who had a special love for garbage trucks. He would spend time on the 12th floor of the University of Iowa Stead Family Children's Hospital overlooking Kinnick Stadium and would watch Hawkeye football games and participate in the iconic Wave tradition. Reid would also point out all the green and yellow garbage cans around the stadium. He would watch for garbage trucks and identify which companies they belonged to during family car trips.

During a stay at the Mayo Clinic in Rochester, Minnesota, for treatment, Reid toured two garbage and recycling centers, as well as the McNeilus Companies facility where garbage trucks are made. During his fifth birthday party, the city of Davenport organized a garbage truck parade past his house in his honor.

Turning loss into a legacy

As a legacy to their son, the Gleesons founded the Rally For Reid Foundation

to support other families facing this devastating diagnosis. The Foundation helps provide support for the entire family, allowing families to stay together during the difficult times they are facing.

"We felt a great loss and emptiness after we lost Reid," Megan said. "After we started the Foundation and started to receive messages from the families it benefitted, it helped fill that void and gave us a sense of purpose."

The Foundation supports the Stead Family Children's Hospital and a variety of research efforts dealing with pediatric brain tumors. Its mission is to provide support for families and children affected by pediatric cancer and to raise funds for vital research.

Supporting families when they need it most

The Foundation has funded several programs to assist with travel expenses and ensure families have access to meals at the hospital so they can stay with their child without having to leave or skip meals. It also provides Family Care packages with essential items and comforting treats to help keep family spirits up during treatment at the hospital.

To date, the Foundation has helped more than 300 families, raised nearly \$250,000 and provided care packages to nearly 200 families of children battling cancer.

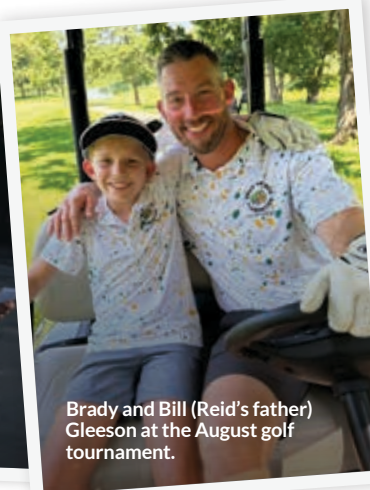

NEVER FORGET

Would you believe about one-third of Americans are too young to have any personal memories of the Sept. 11, 2001, terrorist attacks? It's also hard to fathom that 2026 marks the 25th anniversary of that horrendous day.

In 2001, I was working from my home near Grimes that Tuesday morning, writing articles for AgWeb.com. My landline phone rang shortly before 9 a.m. My colleague demanded that I turn on the TV.

I had no idea what she was talking about, but I went to the living room and grabbed the remote control. Like millions of other Americans, I watched in disbelief as a second airplane hit the World Trade Center. I couldn't turn away as more updates came in. Something hit the Pentagon! A plane crashed in Pennsylvania! What next? Would one hit Chicago? Omaha?

In the days ahead, we learned that terrorist attacks had left nearly 3,000 people dead in New York City, Washington, D.C., and Shanksville, Pennsylvania.

A day no one will ever forget

I recently asked my friends and acquaintances about their memories of 9/11.

"I was working in the Sac County courthouse," said JoAnn Ellerbrock of Lytton. "I heard the breaking news on the radio when the first plane hit. I couldn't believe what I was hearing. Our son was in college. I remember calling to check on him. It was kind of like when I was in grade school, and our superintendent told us President Kennedy had been shot."

Jon Hollatz, a Garner-area farmer, was hauling old-crop corn to town. "The news came across the radio tuned to KWMT 540 AM in the '69 Ford straight truck. My grandpa and I turned on the TV during the lunch hour. That day reminded him of Pearl Harbor in 1941."

Katie Daniel, whose family farms in Carroll County, was eating breakfast when the morning news was interrupted. "It sounded like an accident involving one of the World Trade Center towers. Within minutes, the second plane came, and terrorism was mentioned. I was in disbelief the rest of the day and was praying through it all."

Sac City-area farmer Gary Langbein was headed to the Clay County Fair when he heard the news on the radio. "We found out it was not an accident. A lot of people at the fair were watching all the TVs for sale at the vendors' booths. I remember some people were worried that the fair might get hit."

For Lake City-area farmer Barb Richardson and her husband, Eric, Sept. 11 started as an ideal day to chop corn silage. "The weather was so perfect. Not too hot, and the sky was a bright blue with the prettiest puffy clouds. When the first plane hit, I heard the news over KWMT.



We only had AM radios in those straight trucks. It sounded like a tragic accident. And then the next plane hit the towers, and the third into the Pentagon. My mother-in-law videotaped the news broadcasts, so we could watch them later."

Melanie (Hjelm) Bloom, the ag teacher and FFA advisor at Sioux Rapids High School, was a senior at Iowa State University. "Some friends met me after class and filled me in. I remember how quiet the campus was, maybe an hour after the attacks happened. The phone lines were so busy it was hard to get a call home."

Remembering why it still matters

What a different world that was.

Today, a quarter century later, we must never forget the tragic day that changed America. We must continue to share our memories so those born after 9/11 learn its significance and enduring legacy.
